



Memorandum of Understanding

between

Kurdistan University of Medical Sciences (I.R. Iran)

and

Chongqing Institute of Green and Intelligent Technology, Chinese Academy of Sciences, China

Recognizing the importance of academic, research and technological cooperation between universities and, research centers for active engagement of academic members and researchers in the domain of science and technology and in order to expand scientific and cultural ties between the Islamic Republic of Iran and China, (Kurdistan University of Medical Sciences, Iran) (Pasdaran Blvd., Sanandaj, P.C.: 66177-13446) and (Chongqing Institute of Green and Intelligent Technology, Chinese Academy of Sciences) (Hereinafter referred to collectively as the "Parties") agree to collaborate in the field of academic and scientific collaboration as follows:

Article 1 Objective

This Memorandum of Understanding (hereinafter referred to as the "MoU") aims to promote and develop cooperation between the Parties in areas of mutual interest on the basis of the principles of reciprocity and mutual benefit.

Article 2 Areas of Cooperation

- 2.1 To exchange scientific and scholarly periodicals,
- 2.2 To exchange scientific data, books, scientific publications and, scientific and research documents in the educational, research and technological areas of mutual interest,
- 2.3 To exchange articles to be published in the related periodicals, ·
- 2.4 To publish books and periodicals jointly prepared,
- 2.5 To mutually provide facilities mean: for collaboration in scientific and scholarly activities,
- 2.6 To exchange professors, students, researchers and administrative staff for the purpose of implementing educational /research studies and to participate in conferences, workshops, symposia, and international meetings,
- 2.7 To hold joint specialized conferences, seminars, workshops and training courses,
- 2.8 To provide mutual facilities required for sabbatical leaves,
- 2.9 To collaborate in the development of new academic courses,
- 2.10 To cooperate in the field of opening joint educational courses and joint educational dual-degree programs,
- 2.11 To exchange experiences in various scientific, academic, and research fields,
- 2.12 To inform each other about upcoming international fairs and exhibitions in the field of education, organized by the Parties,
- 2.13 To collaborate in the field of joint supervision of Master Dissertation and PhD Thesis.





Article 3 Expenses

- 3.1 The present MoU involves no financial obligations on the Parties.
- 3.2 Financing any of the afore-mentioned activities shall be subject to mutual agreement.
- 3.3 The parties shall exert their best efforts to procure funding from internal or external sources, so as to ensure the feasibility of the cooperation programs.

Article 4 Duration, Mode, and Termination

- 4.1 The manner of commencement and perpetuation of cooperation by and between the parties shall be decided upon and duly adopted by the representatives appointed by the parties.
- 4.2 This MoU shall remain valid for five years and will be automatically renewed for periods of the same duration unless one of the Parties decides to terminate it. In this case, unwillingness to continue collaborations must be announced six months before the expiration date.
- 4.3 The termination of this MoU shall not affect the implementation of the projects or programs established under it prior to termination.
- 4.4 All disputes arising from the interpretation, development, modification, resolution or execution of the present agreement, must be settled by mutual agreement and through consultation or negotiation between the Parties.
- 4.5 Any changes to the terms and conditions of this MOU and any addenda to it shall become effective by means of a supplementary document mutually accepted by the signatory parties.

Article 5 Official Language and Interpretation of the MoU

The present MoU comprising five Articles was drawn up and duly signed in two copies, each of the same, having equal validity on the date below, in English, and shall take effect and go into force as of the same date.
